



## **Just Health Community Organizer**

**Summary:** The **Just Health Community Organizer** will support the Partnership for Southern Equity's health equity work as aligned with *The Two Georgias Initiative (TGI)*; and play a key role in the Partnership for Southern Equity's statewide health equity expansion, visibility and impact.

**Primary Role:** The primary role of the Just Health Organizer is to engage underrepresented populations, provide support for the Partnership for Southern Equity's Just Health special project and the *Two Georgias Initiative*, a community investment of the Healthcare Georgia Foundation; and to ensure the advancement of health equity as the core value of the collaborative.

### **Role and Responsibilities:**

- Provide project support for the Just Health special project and *The Two Georgias Initiative*
- Identify and build mutually beneficial relationships with key stakeholders in underrepresented communities
- Support and provide tools and resources to strengthen community engagement and outreach
- Develop and maintain relationship with TGI coaches, project coordinators, and grantee partnership groups
- Identify health equity community building strategies to enable residents to participate fully in shared decision-making
- Identify culturally and literacy appropriate tools and resources to communicate health equity
- Participate in staff and program meetings, including *The Two Georgia Initiative* management team meetings, and grantee/partnership meetings, as needed
- Provide timely administrative documentation for all assigned duties, including quality meeting notes for all community meetings
- Perform other duties as assigned by the Partnership for Southern Equity vice president of strategy and engagement and the Just Health consultant
- Represent the Partnership for Southern Equity and Healthcare Georgia Foundation in a professional and ethical manner at all times

### **Experience and Skills Desired for This Position:**

- Possess a strong commitment to racial equity, social justice and systems change
- Minimum 2-5 years of experience in health-related community building and/or health disparities focused on racial equity and/or poverty issues
- Understanding of the social determinants of health and equity
- Experience in working effectively with diverse populations and communities
- Familiarity with and an openness to different approaches to working with low-income and rural communities

- Ability to build consensus, and effectively with diverse groups of people
- Experience in community organizing training, including basic principles of community organizing, building and maintaining relationships built on trust and transparency, and leadership development
- Excellent communication (oral and written) and technology skills
- Ability to work remotely, manage assignments and meet deadlines with minimal supervision. Some travel required.
- Strong team player, familiar with team dynamics and willingness to work in a team environment.

**Preferred Skills:**

- Knowledge of language other than English encouraged
- Strong commitment to equity, justice and inclusion
- Strong people skills, and ability to exercise good judgement under pressure for integrity, ethical behavior, loyalty, and trustworthiness
- Problem-solver with ability to assess situations, gather relevant information, and recommend possible courses of action
- Excellent written and verbal communication skills, including public speaking
- Ability to thrive in face-paced environment
- Strong technology skills for creating documents, databases, spreadsheets, and other communication tools
- Ability to travel, as required
- A good heart; and a sense of humor
